



**Terms and Conditions for the Member Appreciation 110 Days of Giveaways Promotion at Brooke Telecom**

**Promotion is open to:**

All Members of Brooke Telecom Co-operative

**Dates:**

August 1st, 2021- December 31, 2021

**How to Participate:**

Beginning the week of August 1st, 2021, and ending December 31<sup>st</sup>, 2021, Brooke Telecom will be conducting a daily draw (for a total of five (5) draws per week) for a prize valued at Approximately \$10 CAD - \$100 CAD All current members of Brooke Telecom Co-operative will be automatically entered into the draw and a randomized electronic draw will take place to determine the winner. Once a prize has been awarded to a member, that member will NOT be included in any subsequent draws.

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.** If a Non-Member of Brooke Telecom Co-operative wishes to enter the contest, they just need to stop in at a location to enter in a manual ballot. **ELIGIBILITY:** The 110 Days of Giveaways is open to legal residents of Ontario Canada, who are eighteen (18) years of age or older at the time of entry and are Members of the Brooke Telecom Co-operative or have entered through a manual ballot. Employees of Brooke Telecom and the Board of Directors, members of any such employee's immediate family (regardless of where such family members live) and persons with whom such employees reside (whether related or not) are ineligible to enter or win. "Immediate family" is defined as (a) spouses or domestic partners and (b) natural, step, foster, in-law or adoptive parents, siblings and children and their respective spouses and domestic partners. Illegible or incomplete entries will be disqualified. With respect to any potential winning entry, the potential winner may be required to provide proof of identification.

**DRAWS AND PRIZES:**

There are a total of One Hundred and Ten (110) prizes available to be won during the promotional period. Draws will take place each week for a total of five (5) draws per week for the duration of the promotion. Draws will take place electronically using a Random Winner website. Winners will be posted on Facebook, Brooke Telecom's website, or each Brooke Telecom Store will have a copy of the winners. All prize details not specified in these Official Rules will be determined by Brooke Telecom at their sole



discretion. The potential winner will be notified by phone (or by another method) using current contact information associated with Brooke Telecom.

Brooke Telecom will attempt to notify the potential winner within three (3) business days of the applicable drawing. Brooke Telecom shall have no liability if a winner notification is lost, intercepted, or not received by the potential winner for any reason. If the potential winner does not respond within the time frame of the promotion, or if, despite reasonable efforts, the prize notification is returned as unclaimed or undeliverable to the potential winner, the potential winner will be disqualified, and will forfeit his or her prize. A potential winner must complete and sign the Release Form and present valid identification to claim the prize.
