

Construction Permission Form

Brooke Telecom Co-operative Limited is running fibre optic cables past your home. This will allow us to offer high speed internet, digital television, as well as local home phone service to your home!

We ask the **property owner** to **please sign below** to allow an authorized Brooke Telecom representative and/or contractor access to your property to map, locate, dig, plough, and/or trench to install a buried fibre optic line to your home.

When installing buried services, Brooke Telecom Co-operative Limited and our contractor will follow industry safety standards to locate existing utility lines. However, private utility lines such as Dog Fences, Septic Tanks, Weeping Beds, Hydro Services, Sprinkler Systems, Tile Drains, Existing Telephone Line, Buried Lines to Outbuildings, etc. are not part of a standard locate. In an effort to prevent damaging private utilities, please let us know of any underground private lines of which you are aware.

On the blank map, please outline your property showing where these utilities are located. Please place enclosed flag at your preferred access point and mark the flagged location on the map. We would like to bury the fibre line to the appropriate access point. If you would like to consult with a Brooke Telecom tech, please call 519-844-2185 to arrange a site visit.

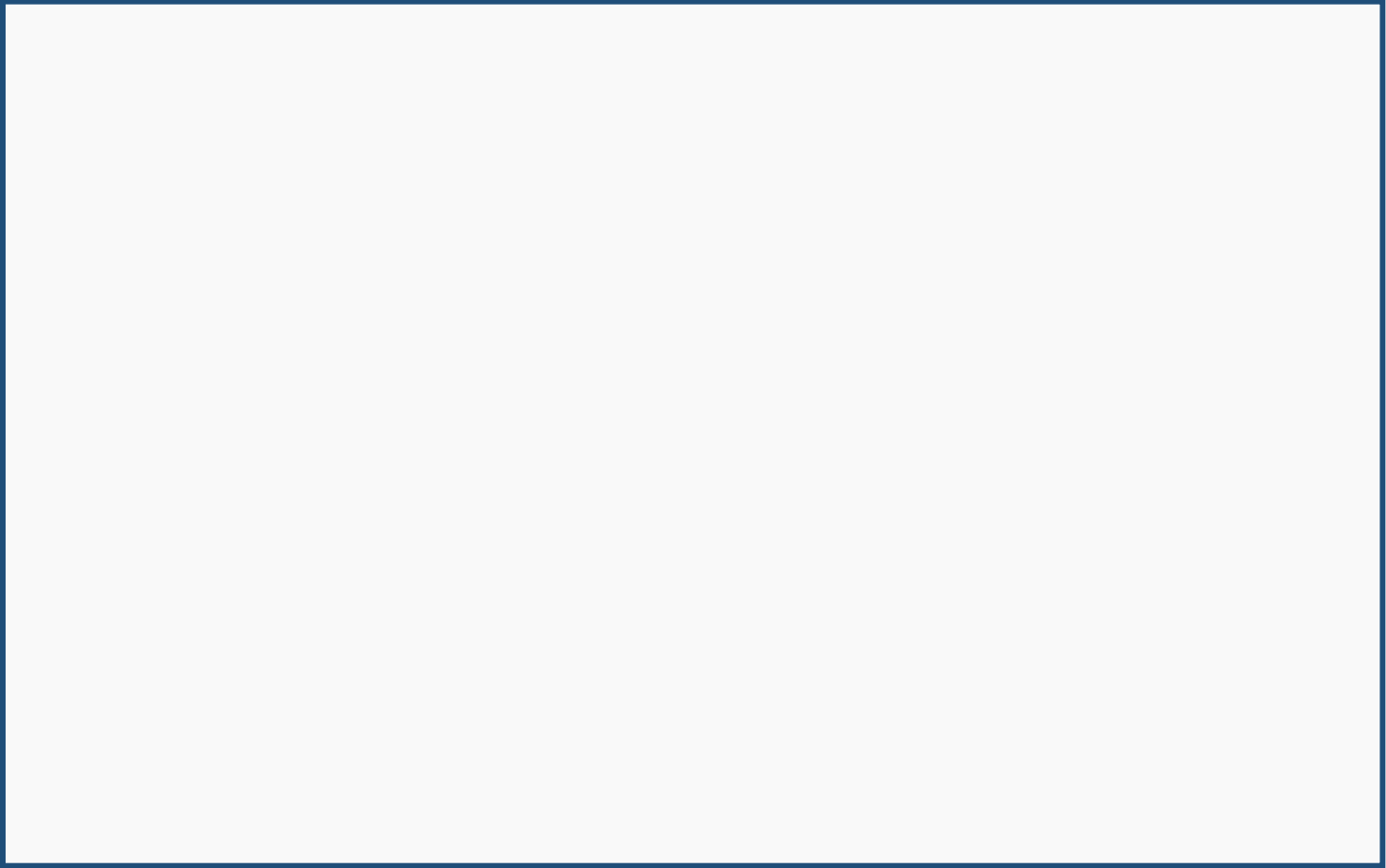
I further submit that I am the legal owner of the property listed. I understand that there will be no construction charges for a standard installation of this underground fibre optic line.
