

Construction Permission Form

Brooke Telecom Co-operative Limited is running Fibre Optic cables past your home. This will allow us to offer high speed internet, digital television, as well as local home phone service to your home!

We ask the **property owner to please sign below** to allow an authorized Brooke Telecom representative and/or contractor access to your property to map, dig, plough, and/or trench to install a buried fibre optic line to your home.

I/we further submit that I am the legal owner of the property listed. I/we understand that there will be no construction charges for a standard installation of this underground fibre optic line.

I/we hereby grant Brooke Telecom Co-operative Limited and its contractor permission to construct, operate and maintain a communications fibre strand from a point on the municipal right of way to my dwelling or business.

When installing buried services, Brooke Telecom Co-operative Limited and our contractor (Pickards) will follow industry safety standards to locate existing utility lines. However, private utility lines such as Bell Canada service wires, sprinkler systems, buried lines to out buildings, septic systems, weeping beds etc. are not a part of the standard locate. In an effort to prevent damaging private utilities, please let us know of any private underground lines you are aware of. Please indicate on the diagram on Page 2 of all known underground wires, pipes, customer buried equipment and the current location of your household utility room, including the electrical panel. We would like to bury the fibre line to where we can bring it into a utility room.

I/we understand that I/we are solely responsible for any damages incurred as a result of my failure to point out any obstruction or failure to be on site during any work performed by Brooke Telecom Co-operative Limited and its contractor.
